AMENDMENT TO RESTRICTIVE COVENANTS OF
MOUNT OLYMPUS ACRES NO. 7

THE UNDERSIGNED, a majority of the property owners of Mount Olympus Acres No. 7, a part of a subdivision, according to the official plat thereof on file and of record in the office of the Salt Lake County Recorder of the State of Utah

TO WHOM IT MAY CONCERN:

ON NOVEMBER 16, 1955, certain restrictive covenants were recorded in Book 1258, Page 229, of the Salt Lake County Recorder, pertaining to the above Mount Olympus Acres No. 7 Subdivision. On December 2, 1955, an amendment to the covenants was recorded in Book 1263, Page 426.

PARAGRAPH (H) of the subject restrictive covenants notes that the covenants shall be binding until April 1, 1979, at which time they shall terminate unless sooner renewed by a majority of the persons owning lots in said subdivision.

THE UNDERSIGNED, wishing to continue and retain the character and excellence of this unique neighborhood, herewith extend from the date hereof until March 1, 1989, the restrictive covenants presently in effect, at which time said covenants shall automatically be extended for successive periods of ten years unless by a vote of a majority of the then owners of the lots it is agreed to change or amend said covenants in whole or in part.

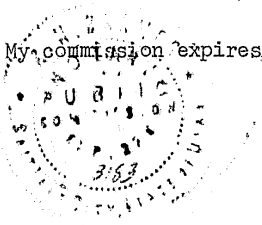
