AMENDMENT TO PROTECTIVE COVENANTS

WHEREAS, on the 19th day of May, 1978, there was recorded in the office of the County Recorder of Salt Lake County, Utah, as Entry No. 3111091, in Book 4676, Page 297, a document for PIONEER ESTATES NO. 4, a subdivision, providing for the use and restrictions on use of the lots in said PIONEER ESTATES NO. 4, and

WHEREAS, it is deemed necessary and for the best interest of the subdivision and the occupants thereof that said protective covenants be amended to correct Paragraph 3 of Part B, Residential Area Covenants.

NOW, THEREFORE, the undersigned H. N. MANAGEMENT, INC., a Utah Corporation, as recorded in the office of the Salt Lake County Recorder, do hereby amend the Protective Covenants recorded in said Book 3811, Page 382, and hereinabove referred to as follows:

3. Dwelling Cost, quality and size. No dwelling shall be permitted on any lot at a cost of less than \$50,000.00, including lot, based upon cost levels prevailing on the date these covenants are recorded, it being the intention and purpose of the covenants to assure that all dwellings shall be of a quality of workmanship and materials substantially the same of better than that which can be produced on the date these covenants are recorded at the minimum cost stated herein for the minimum permitted dwelling size. The ground floor area of the main structure, exclusive of one-story open porches and garages, shall be not less than 1050 square feet for a one-story dwelling, nor less than 950 square feet for a dwelling of more than one story.

EXCEPT as herein amended, all of the Protective Covenants as set forth in said Book 4676, Page 297, are hereby confirmed and approved.
