Jordanelle Special Service District Roadway and Utility Easement Agreement

This AGREEMENT AND GRANT OF EASEMENT (this "Agreement"), made this 17 day of Deptember, 2007, by and among STICHTING MAYFLOWER RECREATIONAL FONDS, an association formed under the laws of the Netherlands and STICHTING MAYFLOWER MOUNTAIN FONDS, an association formed under the laws of the Netherlands (collectively, "Grantor"), and JORDANELLE SPECIAL SERVICE DISTRICT, its successors and assigns (the "District") as grantee.

RECITALS

- A. The District (with offices located at 10420 N. Jordanelle Blvd., Heber City, Utah 84032), a service district organized and existing under the laws of the State of Utah, is in the process of developing and constructing a roadway system, along with water, wastewater and other utility systems necessary to serve the property owners and/or residents of the District.
- B. As part of these improvements, the District will develop and construct phase one of a roadway known as the "Jordanelle Parkway."
- C. Grantor is the owner of certain real property over which a portion of phase one of the Jordanelle Parkway is designed to cross.
- D. The District has requested, and Grantor is willing to grant the easements contemplated by this Agreement to the District to enable the development and construction of phase one of the Jordanelle Parkway and related improvements.

AGREEMENT:

NOW, THEREFORE, in consideration of the benefit of access to the roadway, water and sewer system improvements and/or other utilities which shall provide service to Grantor's property, the right to take advantage of easements provided by other property owners for roadways, water and sewer system improvements, and other utilities, and other good and valuable consideration, the sufficiency of which is hereby acknowledged, Grantor, as the owner

of the parcels of land herein described, does hereby grant and convey unto District, the following Easements

- 1. A non-exclusive easement over, under, across and through the real property described on Exhibit "A," which is attached hereto and incorporated herein by this reference (the "Easement Property"), to survey, clear, excavate, lay, construct, operate, inspect, maintain, protect, repair, replace or remove roadways, water system improvements, wastewater system improvements, maintenance and access roads, and any other public utility deemed necessary by District along a route on, under, across and through the Easement Property (the "Easement"). Certain of the parcels included in the Easement Property are designated as slope easements only, and the easement rights with respect to such parcels shall be limited to the right to construct thereon cut and/or fill slopes and appurtenant parts thereof incident to the construction of the Jordanelle Parkway. Drawings of the Easement Property are attached hereto as Exhibit "B" and incorporated herein by this reference.
 - 2a. District will consult in advance with Dan Matta, Dominion Engineering, to review design issues and resolve appropriately grading, fill and drainage issues in conjunction with the proposed development, and intersections shall be located as designated by Mr. Mayflower, and in compliance with the Wasatch County Development Code.
 - 2b. District and their design engineers will work with Mayflower and their design engineers in reaching a solution to the design and construction of Jordanelle Parkway that will mitigate the slope easement on Mayflower's East Park lots 232, 233 and 234. The design solution could include retaining walls or a combination of slopes and retaining walls. The design and construction of any solution will need to be cost efficient, design guidelines.
- Exhibit "B", during the initial construction of the roadway, water system improvements, sewer system improvements, or other public facilities, and appurtenances belonging to such improvements, for the accommodation of construction equipment, materials and excavated earth. The temporary construction easements for the use of those portions of the property lying outside the boundaries of the Easement shall cease and terminate improvements by District or Wasatch County, and upon full performance by District of the construction easement.

Said grant of easement is subject to the following conditions, exceptions and reservations:

A. This Easement shall be non-exclusive. Grantor may grant other easements, including but not limited to other utility easements on the same property; provided however, Grantor may not build or construct, or in any way permit to be built or constructed, any building, utility improvement, landscaping or other improvement, including other utilities, over or across the Easement described herein, or otherwise alter the property which is subject to the Easement,

in a manner which will in any way unreasonably interfere with District's facilities, or interfere with District's ability to construct, operate, maintain, repair or replace its facilities or other utilities, or any part thereof without the written consent of the District. District shall have the unilateral right to remove any such building, landscaping or other improvement built upon the permanent easement without the prior written consent of the District.

- B. This Agreement shall automatically terminate upon recordation of a plat evidencing dedication of all or a Portion of the Easement Property to the District or Wasatch County for the Jordanelle Parkway. Grantor agrees to sign said plat to complete the dedication of the Easement Property to the District or Wasatch County for public use as the Jordanelle Parkway.
- C. Waiver by either Grantor or District of any breach of any condition or provision of this Agreement shall be limited to the particular instance and shall not operate or be deemed to waive any future breach or breaches of said condition or provision and shall not be deemed to be a modification of this Agreement. The failure of either Grantor or District to insist, in any one instance or more, upon the performance of any of the conditions or provisions of this Agreement or the exercise of any right or privilege herein conferred, shall not be construed as thereafter waiving any such condition, provision, right or privilege, but the same shall continue and remain in full force and effect.
- D. Following the completion of construction and prior to the execution of a dedication plat for phase oneof the Jordanelle Parkway, District shall cause the temporary construction easement to be returned as nearly as possible to its original condition, and shall cause it to be re-seeded with the common seed mix used by the District in utility easements..
- E. District shall indemnify and hold Grantor harmless from and against any loss, cost, damage or expense, including claims for death or injury to person or damage to property, and including without limitation attorneys' fees and court costs, which may arise out of or in connection with or by reason of use of the Easement by the District.
- F. Any notice, demand, request, consent, submission, approval, designation, or other communication which either party is required or desires to give to any other shall be in writing and shall be sent by United States Postal Service by registered or certified mail, return receipt requested, addressed to the other party at the following address, or such other address as indicated in writing by such party:


Maps of Easement Property
