REPORT OF CHANGE OF PLACE OF USE OF WATER

The undersigned owner of the water-right for irrigation of 18.00 acres of land, evidenced by water-right Application for Lands in Private Ownership, Serial No. 3415, recorded in Book ---, Page ---, of contracts in the Office of County Recorder of Utah County, Utah, upon which Construction Costs have been paid in full, has changed the place of use of 4.00 acre feet of said water-right from the following land, designated as Tract 1, and described as follows:

The North West Quarter of the South East Quarter of Section 5, and the North half of the South West Quarter of the South East Quarter of Section 5, Township 10 South, Range 4 East, and the North half of the North East Quarter of the North West Quarter of Section 8, Township 10 South, Range 4 East, SLB&M.

This water to be made appurtenant to the following described piece of land; designated as Tract 2, and described as follows:

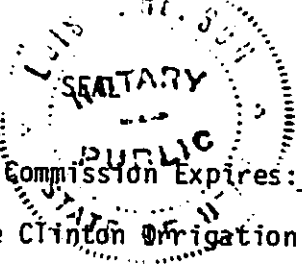
