JUDGMENT

Pursuant to Utah Code Ann. § 78B-5-205 and Rule 58A(f) of the Utah Rules of Civil Procedure, and the *Verified Statement for Judgment by Confession* submitted by Zeus Investments, LLC ("*Zeus*"), the Court hereby enters judgment in favor of Zeus and against Defendants Truman Marketing, LLC, BlueMountain, Inc., Bluem Holdings, LLC, BM3, LLC, BM RE LLC, Bluem Utah, LLC, and Kenneth T. Thomson (together, "*Defendants*") as follows:

WHEREFORE, by virtue of the law, and by reason of the premises aforesaid, it is hereby ORDERED, ADJUDGED AND DECREED that Plaintiff is awarded Judgment against Defendants, jointly and severally, in the amount of \$1,593,575.34 as follows:

- 1. For **\$1,500,000.00**, representing the principal judgment amount.
- 2. For non-default pre-judgment interest at the rate of 8% per annum from September 19, 2022 through April 11, 2023 (204 days), totaling **\$67,068.49**.
- 3. For default pre-judgment interest at the rate of 15% per annum from December 12, 2022 through May 24, 2023 (43 days), totaling **\$26,506.85**.
- 5. Post-judgment interest shall accrue on this Judgment at the rate of 15% per annum pursuant to Utah Code § 15-1-4(2)(a) until this Judgment is satisfied in full. This Judgment may be augmented by attorneys' fees and costs incurred in enforcing this Judgment pursuant to the Utah Rules of Civil Procedure.
- 6. Pursuant to paragraph 9 of the *Verified Statement for Judgment by Confession*, process to enforce the Judgment may be commenced immediately upon entry of the Judgment, and the Court directs that the 28-day delay in execution under Rule 62(a) shall not apply.
- 7. This Judgment shall be deemed satisfied to the extent payments were made under the parties' Forbearance Agreement.
