EASEMENT

Parcel No. 80N-6:206:E
Project No. I-80N-6(11)71

Weldon M. Ercanbrack and Lillian Ercanbrack, his wife, Grantors of Morgan, County of Morgan, State of Utah, hereby grant and convey to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Two hundred and twenty-five and no/100 Dollars, an easement upon part of an entire tract of property in the Lot 1 of Section 27, T. 4 N., R. 3 E., S.L.B. & M. in Morgan County, Utah, for the purpose of constructing thereon a channel change for the Weber River and appurtenant parts thereof incident to the construction of a freeway known as Project No. 80N-6.

Said part of an entire tract is a strip of land 120.0 ft. wide, 60.0 ft. on the southerly side and 60.0 ft. on the northerly side of the following described center line:

Beginning at the intersection of said center line and the east line of said Section 27, which point is approximately 1075.0 ft. south from the NE. corner of said Section 27; thence Westerly 237. ft., more or less, along the arc of a 5,729.58 ft. radius curve to the right to Engineer Station 10+35 (Note: Tangent to said curve at its point of beginning bears approximately S. 78° 33' W.); thence S. 80° 55' W. 35.0 ft.

The above described parcel of land contains 0.75 acre, more or less.

After said channel change is constructed on the above described part of an entire tract at the expense of said State Road Commission, said State Road Commission is thereafter relieved of any further claim or demand for costs, damages or maintenance charges which may accrue against said channel change and appurtenant parts thereof.
