

# RIGHT OF WAY AGREEMENT FOR 3321537 SALT LAKE CITY SUBURBAN SANITARY DISTRICT PIPE LINE

PETER A. GILL and DIANE GILL, his wife,  
of Salt Lake City, Salt Lake County, State of Utah, Grantors, do hereby convey and warrant  
to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing  
under and by virtue of the laws of the State of Utah, Grantee, for the sum of ONE DOLLAR \*\* and  
other considerations DOLLARS (\$1.00) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right  
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through  
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:

Commencing South 0°02' West 2,087.85 feet and South 89°47' East 760 feet from Northwest  
Corner of Northeast 1/4 Section 15, Township 2 South, Range 1 East, Salt Lake Base and  
Meridian North 0°02' East 193.3 feet; North 45°07' East 84.7 feet; South 89°47' East  
337 feet; South 0°33' East 156.9 feet; North 87°45' West 161 feet; South 15°28' West  
106 feet; North 89°47' West 215 feet to beginning.

the center line of said pipe shall extend through and across the above land and premises on a line  
described approximately as follows:

Enters West property line at a point 22 feet North of the Southwest Corner of above  
described property; thence North easterly to a manhole which is 19 feet East of the  
West boundary line; thence North 180 feet parallel to and 19 feet east of the West  
property line; thence Northeasterly to the Northwest Corner of said property. Also  
Southeasterly from said manhole to the South boundary line of property at a point  
50 feet more or less East of the Southwest Corner of said property.

**TO HAVE AND TO HOLD** the same unto the Salt Lake City Suburban Sanitary District so  
long as such pipe line shall be maintained, with the right of ingress and egress to and from said  
right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor....  
to fully use the said premises except for the purposes for which this right of way or easement is  
granted to the said Grantee.
