This matter having come regularly before the Court upon
the _____ day of _____, 1979, and the Court
having made and entered its judgment in the above entitled
proceeding, and said judgment is hereby referred to; and, it
appearing to the Court and the Court now finds that pursuant to
law and said judgment, that Plaintiff has paid said judgment to
the Defendants herein with no interest as provided for §78-34-9
UCA 1953; and, it further appears to the Court that Plaintiff has
made all payments as required by law and by the order of this
Court, and that this is not a case where any bond was required
to be given, and the Court being fully appraised on the premises:

It is hereby Ordered, Adjudged and Decreed:

That the property hereinafter described is hereby taken
and condemned in fee simple, for use in connection with the
expansion of Plaintiff's water purification and treatment plant
for South Salt Lake County.

IT IS FURTHER ORDERED That said use is a public use and
a use authorized by law.

IT IS FURTHER ORDERED That a certified copy of this
final order of condemnation be filed with the County Recorder of
Salt Lake County, State of Utah, and thereupon the fee title in


the premises hereinafter referred to, shall vest in the Plaintiff. The following is a description of the property so ordered and condemned as herein provided, which is hereby vested in fee in Plaintiff, all of which is located in Salt Lake County, State of Utah, and is more fully described as follows:

Beginning at the West 1/4 corner of the Northwest 1/4 of the Southeast 1/4 of Section 16, T4S, R1W, SLB&M, and running thence westerly 419.5 feet along the south boundary of the Northeast 1/4 of the Southwest 1/4 of said Section 16; thence N 60°55'22" W 348.59 feet; thence easterly 724.41 feet along a line paralleling the south boundary of Northeast 1/4 of the Southwest 1/4 of said Section 16 to the Southeast property line of the Central Utah Water Conservancy District Property; thence Southerly 168.8 feet more or less to the point of beginning. Containing 2.2 Acres. Subject to a right-of-way for ingress and egress to defendants remaining properties.
