on Exhibit B to this Easement for the purpose of improving a public roadway and utilities.







EXHIBIT B TEMPORARY CONSTRUCTION EASEMENT

PARCEL A

A Temporary Construction Easement across a portion of Parcel 58:034:0822, located in a portion of the SE1/4 of Section 21, Township 5 South, Range 1 West, Salt Lake Base & Meridian, more particularly described as follows.

Beginning at a point on the East line of said Parcel, located N0°23'51"E along the Section line 731.29 feet from the Southeast corner of Section 21, T5S, R1W, SLB&M; thence S81°35'52"W along said Parcel 51.52 feet; thence N8°24'08"W 15.99 feet; thence northeasterly along the arc of a 349.00 foot radius non-tangent curve (radius bears: S8°55'32"E) to the right 53.61 feet through a central angle of 8°48'04" (chord: N85°28'30"E 53.56 feet) to the east line of said Parcel; thence S0°23'51"W 12.51 feet to point of the beginning.
