SUBORDINATION AGREEMENT

This subordination shall become effective immediately upon recording of the same.

This agreement is for the sole purpose of subordinating the interest of Ogden City Redevelopment Agency, a body politic and political subdivision of the State of Utah to the Trust Deed to Central Bank and for no other reason. The interest of Ogden City Redevelopment Agency, a body politic and political subdivision of the State of Utah shall retain its priority over any other interests or liens of record on the subject property.

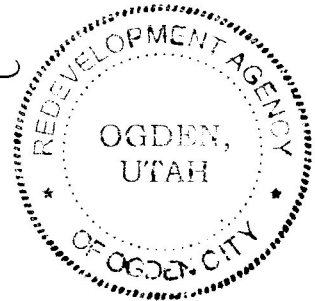

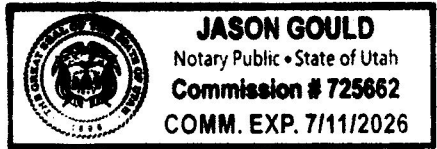
