POLE LINE EASEMENT

Alfred F. Rollow a single man and Mildred I. Rollow, his mother  
his wife, Grantors, of Weber County, Utah, hereby convey and warrant  
to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns,  
Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement  
and right of way for the erection and continued maintenance, repair, alteration, and replacement  
of the electric transmission, distribution and telephone circuits of the Grantee, and  
four guy anchors and two ~~poles~~ poles, with the necessary guys, stubs, crossarms and  
other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and  
maintained upon and across the premises of the Grantors, in Weber County,  
Utah, along a line described as follows:

Beginning on the east boundary fence of the Grantors' land at a point 490 feet  
south and 1340 feet west, more or less, from the east one quarter corner of  
Section 36, T. 6 N., R. 2 W., S.1.M., thence N. 44° 13' W. 696 feet, thence  
N. 89° 39' W. 28 feet to the west boundary fence of said land and being in the  
NE 1/4 of the SE 1/4 and the SW 1/4 of the NE 1/4 of said Section 36.

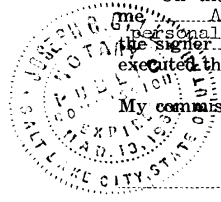

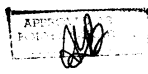
