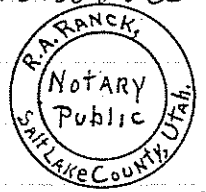

Section Thirty two (32) also East half of North East quarter Section 31. All in Township Three South Range two (2) West Salt Lake Base and Meridian.

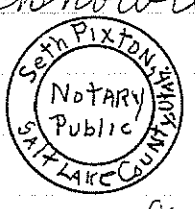
