**FINAL JUDGMENT BY DEFAULT****TO THE HONORABLE JUDGE OF SAID COURT:**

On this day came on to be heard the above-styled and numbered cause wherein DENNIS W. DONLEY, JR. is Plaintiff and SHAUN CARR and SPECIAL BLEND MOTOR GARAGE, LLC (collectively, "Defendants") are Defendants.

Plaintiff appeared by their attorney of record and announced ready for trial. However, Defendants, although duly and legally cited to appear and answer, failed to appear and answer, and wholly made default. The Court finds that citations were served according to law and returned to the clerk where they remained on file for the time required by law. The Court has read the pleadings and the papers on file and finds that Defendants have by their default admitted the allegations of Plaintiffs' Original Petition and, upon good and sufficient evidence presented to the Court of liability and damages, finds that Plaintiff's Motion to Enter Default Judgment should be in all respects granted.

IT IS, THEREFORE, ORDERED, ADJUDGED, and DECREED that Plaintiff is entitled to have and recover of and from Defendants, jointly and severally, the sum of \$215,226.18, same including \$71,742.06 in direct damages plus statutory treble damages, plus



interest on this \$215,226.18 amount at a rate of 8.50% per annum from the date of judgment until paid.

IT IS FURTHER ORDERED, ADJUDGED, and DECREED by the Court that Plaintiff is entitled to have and recover of and from Defendants, jointly and severally, reasonable and necessary attorney's fees in the amount of ~~\$12,562.50~~ <sup>\$7,810.00</sup> and court costs in the amount of \$669.93, plus interest on these amounts at a rate of 8.50% per annum from the date of judgment until paid.

IT IS FURTHER ORDERED, ADJUDGED, and DECREED by the Court that Plaintiff has presented good and sufficient evidence that should this matter be appealed and should Plaintiff prevail on appeal, Plaintiff will be entitled to ~~\$8,300~~ <sup>\$6,400</sup> for representation at the court of appeals, ~~\$4,980~~ <sup>\$2,000</sup> for representation at the petition stage in the Supreme Court of Texas, and ~~\$4,980~~ <sup>\$2,000</sup> at the merits stage at the Supreme Court of Texas.

IT IS FURTHER ORDERED, ADJUDGED and DECREED by the Court that all relief not specifically granted herein is hereby Denied. This Judgment disposes of all parties and claims; it is intended to be final and appealable.

Plaintiffs are allowed such writs and processes as may be necessary in the enforcement and collection of this Judgment.
