Certification of Trust for the Norman and Bonnie King Family Trust dated April 22, 2014

Pursuant to Utah Code § 75-7-1013, this Certification of Trust is signed by the currently acting trustees of the Norman and Bonnie King Family Trust dated April 22, 2014 ("Trust"), who declare:

1. The Trustors of the Trust are Norman King and Bonnie King. Norman King and Bonnie King are the initial trustees of the Trust. The Trust remains revocable and amendable by the Trustors.
2. Pursuant to the terms of the Trust, Norman King and Bonnie King have appointed Nora King Smith as a co-trustee to serve with them by majority vote, and Nora King Smith has accepted such appointment (see *Appointment of Co-Trustee and Acceptance of Co-Trustee* attached hereto as **Exhibit A**). Norman King, Bonnie King, and Nora King Smith now serve as co-trustees of the Trust. The signatures of a majority of the co-trustees is necessary to exercise the powers of the trustee.

4. Trust property may be taken in the name of:

Norman King, Bonnie King, and Nora King Smith, Co-Trustees, or their successors in trust, of the Norman and Bonnie King Family Trust dated April 22, 2014, and any amendments thereto.

5. Any alternative description will be effective to title assets in the name of the Trust or to designate the Trust as a beneficiary if the description includes the name of at least one initial or successor trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the Trust.

6. Excerpts from the Trust document that establish the trust, designate the trustee, and set forth the powers of the trustee will be provided upon request. The powers of the trustee include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests of all Trust property.
7. The terms of the trust provide that a third party may rely upon this Certification of Trust as evidence of the existence of the trust and is specifically relieved of any obligation to inquire into the terms of this trust or the authority of my Trustee, or to see to the application that the Trustee makes of funds or other property received by the Trustee.
8. The Trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.
9. Pursuant to Utah Code § 75-7-1013(2), which allows that a Certification of Trust may be signed by any trustee, the undersigned trustees hereby execute this Certification.
10. This Certification of Trust identifies a successor trusteeship to the prior trusteeship as identified in that certain Warranty Deed recorded with the Weber County Recorder on June 10, 2014, as Entry No. 2689919 ("Deed").
11. This Certification of Trust affects title in the following-described parcels of real property situated in Weber County, State of Utah:


