EASEMENT

GUARDIAN TITLE COMPANY OF UTAH and
 BACKMAN ABSTRACT & TITLE COMPANY, Grantor, of the
 County of Salt Lake, State of Utah, hereby CONVEYS and QUIT
 CLAIMS to DRAPER IRRIGATION COMPANY, Grantee, for the sum of One
 Dollar (\$1.00) and other good and valuable consideration, the
 receipt of which is hereby acknowledged, a perpetual right of way
 and easement to lay, maintain, operate, repair, inspect, protect,
 remove and replace water pipelines, valves, valve boxes and other
 water transmission and distribution facilities, hereinafter
 called "Facilities", said right of way and easement being situated
 in the County of Salt Lake, State of Utah, and more particularly
 described as follows, to-wit:

SEE ATTACHMENT

TO HAVE AND TO HOLD the same unto the said Grantee, its
 successors and assigns, so long as such Facilities shall be main-
 tained, with the right of ingress and egress to and from said
 right of way to maintain and operate, repair, inspect, protect,
 remove and replace the same. During temporary periods Grantee
 may use such portion of the property along and adjacent to said
 right of way as may be reasonably necessary in connection with
 the construction, maintenance, repair, removal or replacement of
 said Facilities, Grantor shall have the right to use said premi-
 ses except for the purpose for which this right of way and ease-
 ment is granted to the said Grantee, provided such use does not
 interfere with the Facilities or any other rights granted to the
 Grantee hereunder.

Grantor shall not build or construct or permit to be
 built or constructed any building or other improvement over or
 across said right of way nor change the contour thereof without
 the written consent of Grantee. This right of way and easement
 grant shall be binding upon and inure to the benefit of the suc-
 cessors and assigns of Grantor and the successors and assigns of
 Grantee, and may be assigned in whole or in part by Grantee.

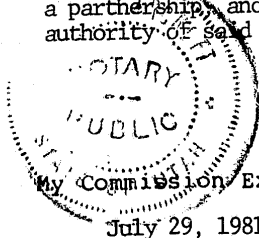

Beginning at a point which is S 89°55'57" E 136.676 feet from the S.W. corner of Canyon Oak Village No. 1; said corner being S 0°09'47" E 2030.604 feet from the center of section 22, T.3S., R.1E., S.L.B.&M.; thence S 0°04'03" W 16.00 feet to a point of tangency with a 1305.442 foot radius curve, the center of which bears S 89°55'57" E; thence Southeasterly along said curve to the left through a central angle of 13°15'14" a distance of 301.98 feet to a point of reverse curve, the bearing between the curve centers being S 76°48'49" W; thence Southeasterly along a 1295.464 radius curve to the right through a central angle of 13°01'24" a distance of 294.459 feet; thence S 0°09'47" E 1040.421 feet to a point of tangency with a 602.497 foot radius curve, the center of which bears S 89°50'13" W; thence Southwesterly along said curve to the right through a central angle of 63°30' a distance of 667.738 feet to a point of reverse curve, the bearing between the curve centers being S 26°39'47" E; thence Southwesterly along a 1164.312 foot radius curve to the left through a central angle of 9°57'30" a distance of 202.364 feet; thence S 53°22'43" W 108.20 feet to a point of tangency with a 590.278 foot radius curve, the center of which bears S 36°37'17" E; thence Southwesterly along said curve to the left through a central angle of 8°20' a distance of 85.853 feet; thence S 45°02'43" W 298.20 feet, to a point of tangency with a 304.191 foot radius curve, the center of which bears S 44°57'17" E; thence Southwesterly along said curve to the left through a central angle of 18°59' a distance of 100.785 feet; thence S 26°03'43" W 622.97 feet, to a point of tangency with a 1811.708 foot radius curve the center of which bears N 63°56'17" E; thence Southwesterly along said curve to the right through a central angle of 10°37'30" a distance of 335.965 feet to a point of reverse curve, the bearing between the curve centers being S 53°18'47" E; thence Southwesterly along a 1844.708 foot radius curve to the left through a central angle of 10°37'30" a distance of 342.085 feet; thence S 26°03'43" W 357.757 feet to a point of tangency with a 695.523 foot radius curve, the center of which bears N 63°56'17" W; thence Southwesterly along said curve to the right through a central angle of 64°04'51" a distance of 777.888 feet, thence N 89°51'26" W 543.076 feet.
