THIS CORRECTED AGREEMENT is made and executed this 10th day of ~~December~~ ^{January}, 19~~79~~⁸⁰, by and between SALT LAKE COUNTY, a body corporate and politic of the State of Utah, hereinafter referred to as COUNTY, and MILTON O. GOLD and LINNIE PARKER GOLD, his wife, of Salt Lake City, Utah, hereinafter referred to as SECOND PARTY.

WHEREAS, the parties hereto entered into an agreement dated August 22, 1979, hereinafter referred to as the original agreement, concerning the installation of curb, gutter and sidewalk abutting property owned by SECOND PARTY located at 10191 South Dimple Dell Road; and

WHEREAS, in the original agreement, the parties, through mutual mistake, incorrectly described the property located at 10191 South Dimple Dell Road; and

WHEREAS, the parties desire to correct the error in the legal description of the said property;

NOW, THEREFORE, it is agreed by and between the parties as follows:

1. The original agreement by and between the parties hereto is amended by correcting the legal description in paragraph A of said agreement to read as follows:

Beginning at a point South 89°02'20"
West 190.46 feet from the South quarter
corner of Section 11, Township 3 South,
Range 1 East, Salt Lake Base and Meridian;
thence North 0°30'49" West 120.00 feet;
thence South 89°02'20" West 80.73 feet;
thence South 0°30'49" East 25.00 feet;
thence South 89°02'20" West 80.00 feet;
thence North 0°30'49" West 5.00 feet;
thence South 89°02'20" West 60.08 feet
to a point beginning on a 922.37 foot
radius curve to the left (bearing to
center South 73°00'13" East), thence
southwesterly 103.46 feet along the arc
of said curve; thence North 89°02'20"
East 246.34 feet to the point of begin-
ning; containing approximately 0.566
acres.


2. The remaining provisions of the original agreement shall remain the same and of full force and effect.
