E A S E M E N T

GLACIO PARK, INCORPORATED, a Utah Corporation, owner of the below described premises, hereinafter "Grantor", hereby grants and conveys to SALT LAKE CITY CORPORATION, a municipal corporation, of the State of Utah, hereinafter "Grantee", for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, a perpetual easement for the construction, maintenance, replacement of the same, or larger or smaller facilities pertaining hereto, and repair of City water-mains, together with service lines, meters and all attendant facilities related thereto, over, under, across and through the following tract of land situation in Salt Lake County, State of Utah, to-wit:

A 20' Right-of-Way, the West line of which is described as follows: Beginning at the Northwest corner of Lot 14, Glacio Park, a subdivision located in Section 12, Township 3 South, Range 1 East, Salt Lake Base and Meridian in Salt Lake County, Utah and running thence South  $1^{\circ}25'57''$  East 310.00, more or less, to the center of Little Cottonwood Creek.

Together with a sufficient right of ingress and egress for the full and complete use, occupation, and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, landscaping and other obstructions which may injure or interfere with the Grantee's access, use, occupation or enjoyment of this easement. Provided, however, this easement is subject to certain Restrictive Covenants recorded against said property on January 10, 1980 with Recorder's Entry Number 3386804, in Book 5023, Pages 173-183A and any limitations affecting this easement therein stated.

Provided, however, that in the event Grantee has not commenced substantial construction with respect to the water facilities described above, within one (1) year from date hereof,




