AMENDMENT TO BUILDING AND USE RESTRICTIONS

WHEREAS, on the 7th day of February, 1979, there was recorded in the office of the County Recorder of Salt Lake County, Utah, as Entry No. 3234439, in Book 4811, at Page 621, a document entitled Declarations of Building And Use Restrictions for CHATTEL ESTATES #4, providing for the use and restrictions on use of the lots in CHATTEL ESTATES #4.

WHEREAS, it is deemed necessary that said building and use restrictions be amended to correct Paragraph 10 of Part B, Residential Area Covenants.

NOW THEREFORE, the undersigned, MIDWEST REALTY & FINANCE, INC., a Utah corporation; DON GOOD AHN and CHERRY YOO AHN, his wife; WILLIAM G. SKEA and DEBORAH M. SKEA, his wife; DOUGLAS L. WINDER and LESLIE M. WINDER, his wife; COATES BROS., INC., a Utah corporation; GEORGE H. BLACK & CO., a partnership; CONTEMPORARY HOME BUILDERS, INC., a Utah corporation, UTOPIA CONSTRUCTION CO., INC., a Utah corporation, the fee owners of CHATTEL ESTATES #4, as recorded in the office of the Salt Lake County Recorder, do hereby amend the Building And Use Restrictions recorded in said Book 4811, Page 621, and hereinabove referred as follows:

10. Livestock and Poultry. No animals, livestock, or poultry of any kind shall be raised bred or kept on Lots 12 - 68 except that dogs, cats or other household pets may be kept provided that they are not kept, bred or maintained for any commercial purpose and are restricted to the owner's premises or on leash under handler's control.

Sheep, cows, horses, dogs, cats and other domestic animals may be kept and maintained on Lots 1 - 11, provided they are not kept, bred or maintained for any commercial purpose and are restricted to owners premises or on leash under handler's control. Mink and pigs shall not be raised, bred or kept on any lot.

EXCEPT as herein amended, all of the Building And Use Restrictions as set forth in said Book 4811, Page 621 are hereby confirmed and approved.
