## POLE LINE EASEMENT

Charles H. Randall and Tressa J. Randall  
his wife, Grantor<sup>s</sup>, of Weber County, Utah, hereby convey and warrant  
to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns,  
Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement  
and right of way for the erection and continued maintenance, repair, alteration, and replacement  
of the electric transmission, distribution and telephone circuits of the Grantee, and  
poles, with the necessary guys, stubs, crossarms and  
other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and  
maintained upon and across the premises of the Grantor<sup>s</sup>, in \_\_\_\_\_ County,  
Utah, along a line described as follows:

Beginning at the east boundary fence on the Grantors' land at a point 1600 feet  
north and 140 feet west, more or less, from the south and quarter corner of  
Section 33, T. 7 N., R. 1 E., S. 1 E., Thence in 32° 37' 11" 35.45 feet to the  
west boundary fence of said land and being in the 1/4 of the 1/4 of Section 33.

Also, beginning at the west boundary fence on the Grantors' land at a point 1600  
feet north and 140 feet west, more or less, from the south and quarter corner of  
Section 33, T. 7 N., R. 1 E., S. 1 E., Thence in 32° 37' 11" 35.45 feet to the  
east boundary line of said land and being in the 1/4 of the 1/4 of Section 33.

Together with all rights of ingress and egress necessary or convenient for the full and com-  
plete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges  
incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches  
and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoy-  
ment of this easement.
