POLE LINE EASEMENT

Charles H. Randall and Tressa J. Randall
 his wife, Grantor^s, of Weber County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and
 no. my anchors and one poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor^s, in _____ County, Utah, along a line described as follows:

Beginning at the east boundary fence on the Grantor^s land at a point 1100 feet north and 140 feet west, more or less, from the south end of the west boundary fence of Section 33, T. 7 N., R. 1 W., S.L.C., thence in 33° 37' 11" S. 77° 15' 45" E. to the west boundary fence on said land and being in line in 1/4 of the 33° 37' 11" S. 77° 15' 45" E. of said Section 33.

Also, beginning at the west boundary fence on the Grantor^s land at a point 1100 feet north and 1130 feet west, more or less, from the south end of the west boundary fence of Section 33, T. 7 N., R. 1 W., S.L.C., thence N. 35° 51' E. 317' 10" S. 77° 15' 45" E. to the east boundary line of said land and being in line in 1/4 of the 33° 37' 11" S. 77° 15' 45" E. of said Section 33.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.


