**RIGHT OF WAY AGREEMENT FOR**

of Salt Lake County ..... State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of one dollar and other consideration

acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in: Commencing at a point located 77.00 rods East, and North 30°45' West 20.50 rods, and North 35°46' West 8.70 feet, and North 65°11' East 241.65 feet, and North 27°04' West 89.67 feet, to the true point of beginning, from the South quarter corner of Section 3, Township 2 South, Range 1 East, Salt Lake Base and Meridian; thence North 27°04' West 219.94 feet; thence North 65°00' East 20.01 feet; thence South 27°04' East 219.94 feet; thence South 65°00' West 20.01 feet to the point of beginning. Area = 4,399 sq. ft. = 0.101 acre

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows: wherever main sewer lines are laid to serve two or more buildings.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.
