

A temporary easement, upon part of an entire tract of property situate in the SW1/4 NW1/4 of Section 36, Township 4 North, Range 1 West, Salt Lake Base and Meridian, for the use of contractor staging area, a driveway reconstruct and appurtenant parts thereof to facilitate the widening of existing US-89, known as Project No. S-0089(406)398. This easement shall commence upon the beginning of actual construction on the property and shall continue only until project construction on the property is complete, or for three (3) years, whichever first occurs. The easement shall be non-exclusive such that the Grantor may use the property at any time in a manner which does not interfere with construction activities. The boundaries of said part of an entire tract are described as follows:
