NOW, THEREFORE, for the feregoing purposes, the Association hereby makes the following declarations and amendments.

I. The Board of Trustees of the Association, and each of them, certify that a vote as required by the terms and conditions of Article XVI has occured and that pursuant to said vote, the Association does hereby amend the Declaration of Condominium for Prowswood Plaza.

II. That said Declaration is amended by substituting an amended Exhibit "B" to Declaration of Condominium for Prowswood Plaza (as amended - September 4, 1980), a copy of which amended Exhibit "B" is attached hereto and incorporated herein by reference.
