Right of Way for Road through the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ Section 12, Township 13 South, Range 8 East, S .L.B.&.M.

Beginning at a point which bears South 1 degree 10' West a distance of 123 feet from the East quarter corner of Section 12, Township 13 South, Range 8 East, Thence South 65 degrees 57' West 167.5 feet, thence South 50 degrees 45' West 293.8 feet, Thence South 53 degrees 37' West 150.4 feet, Thence South 84 degrees 48' West 169.75 feet, Thence South 69 degrees 13' West 131 feet, Thence North 87 degrees 04' West 163 feet, Thence South 56 degrees 12' West 172.5 feet, Thence due West 40 feet to intersection with line between the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ and the NW $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 12, Township 13 South, Range 8 East.

Right of Way to consist of a strip 25 foot wide on each side of above described center line.
