On March 3, 2023, the Court entered the Order Granting Ex Parte Emergency Verified Motion for Temporary Restraining Order (the "Order"). In the Order, the Court scheduled a hearing on the injunctive relief requested by the Plaintiff. On March 10, 2023, the Court held a hearing at 4:00 PM on plaintiff's motion for preliminary injunction. Present at the hearing were Brett N. Anderson, counsel for Plaintiff, and several witnesses. Neither Synergy Title Insurance Agency, LLC nor Ryan Goodrich appeared at the hearing and no return of service had been filed confirming service on the defendants. The Court, therefore, continued the hearing to April 7, 2023. As stated in open court, given the continuance of the hearing on the motion for

preliminary injunction, the Court extended the TRO entered on March 3, 2023 to April 7, 2023 and scheduled the next hearing for April 7, 2023 at 9:00 AM in the Farmington courthouse.
