



**Parcel 1: (01-047-0356)**

Commencing at a point on the East line of a county road, said point being 3005.5 feet West and 1504.7 feet North from the South Quarter Corner of Section 1, Township 1 North, Range 1 West, Salt Lake Meridian, United States Survey, and running thence North 0°03' West 66 feet; thence North 89°06' East 220.0 feet; thence South 0°03' East 66.0 feet; thence South 89°06' West 220.0 feet to the point of commencement.

**Parcel 2: (01-047-0355)**

Beginning at a point 3005.5 feet West and 1504.7 feet North and North 89°06' East 220 feet from the South Quarter Corner of Section 1, Township 1 North, Range 1 West, Salt Lake Base and Meridian, and running thence North 0°03' West 66 feet; thence North 89°06' East 440.0 feet; thence South 0°03' East 66 feet; Thence South 89°06' West 440.0 feet to the point of beginning.
