15.176.0103 FIRST AMENDMENT TO DEVELOPMENT AGREEMENT

This First Amendment to Development Agreement (this "Amendment") is made and entered into this \(\subseteq \frac{\sqrt{\text{M}}}{\text{day}} \) day of \(\subseteq \frac{\text{M}}{\text{M}} \), 2023, by and between **Syracuse Land Holdings**, **LLC**, a Utah limited liability company (the "Developer"), an affiliate of Wasatch Residential Group, LLC, a Utah limited liability company, and successor-in-interest to its rights under the Development Agreement (defined below), **Columbia Ogden Medical Center**, **Inc.**, a Utah corporation ("Owner"), and **Syracuse City**, a municipality and political subdivision of the State of Utah (the "City").

RECITALS:

- A. Wasatch Residential Group, LLC, an affiliate of Developer, Owner and the City entered into that certain Development Agreement dated June 15, 2022, and recorded October 3, 2022, as entry 3501369 in the official records of the Davis County recorder's office (the "Development Agreement"), in connection with the development of certain real property in Syracuse, Davis County, Utah, as more particularly described in the Development Agreement (the "Property").
- B. Owner had acquired the Property pursuant to that certain Purchase and Sale Agreement dated January 20, 2021 (the "CHC Purchase Agreement"), for the purchase of a portion the Property from The Church of Jesus Christ of Latter-day Saints, a Utah corporation sole, formerly known as Corporation of the Presiding Bishop of the Church of Jesus Christ of Latter-day Saints, a Utah corporation sole ("CHC").
- C. The CHC Purchase Agreement specifically excluded from the sale to Owner a portion of the Property subject to the Utah Department of Transportation's widening of 2000 West and Highway 193 in Syracuse, Davis County, Utah, which was to be conveyed to Utah Department of Transportation pursuant to a separate agreement (the "UDOT Property").
- E. By mutual mistake, CHC conveyed to Owner, and Owner accepted from CHC the UDOT Property, whereby Owner subsequently conveyed to Developer, and Developer accepted from Owner, the UDOT Property.
- F. The parties now desire to amend the Development Agreement to amend the legal description of the Property to exclude the UDOT Property according to the terms and conditions set forth herein.

NOW THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Developer, Owner and City hereby agree to the following:

- Incorporation of Recitals. The foregoing Recitals are hereby incorporated into this Amendment and made a part hereof.
- 2. Exhibit A. Exhibit A of the Development Agreement is hereby deleted in its entirety and replaced with Exhibit A, attached hereto and incorporated herein.
- Exhibit A-1. Exhibit A-1 of the Development Agreement is hereby deleted in its entirety and replaced with Exhibit A-1, attached hereto and incorporated herein.
- Ratification of Development Agreement. Except as expressly modified by this
 Amendment, the parties hereby ratify the Development Agreement and agree that the Development
 Agreement shall remain in full force and effect.
- 5. Amendment to Development Agreement. To the extent that the terms and conditions of this Amendment modify or conflict with any provisions of the Development Agreement, including prior addenda, schedules and exhibits, the terms of this Amendment shall control. All other terms of the Development Agreement, including all prior addenda, schedules, and exhibits, not modified by this Amendment shall remain the same.
