Based on the Court's Findings of Fact and Conclusions of Law dated July 7, 2023, and for all of the reasons stated therein, the Court now enters a FINAL JUDGMENT pursuant to Utah R. Civ. P. 54 and 58A, as follows:

- Plaintiffs' claims for quiet title, part performance, and declaratory judgment are
 DENIED with prejudice.
 - 2. Plaintiffs' claim for unjust enrichment (solely related to a \$97,551 earnest money

deposit at issue in the case) is GRANTED. Plaintiffs will be granted a credit against amounts owing to Defendants as set forth below.

- Defendants' claims for wrongful lien and breach of contract are DENIED with prejudice.
- Defendants' claim for quiet title is GRANTED. Title to the Bella Vista Home (the residence located at 2133 Bella Vista Drive in Farmington, Davis County, Utah) is to be quieted in favor of Defendants.
- 5. Defendants' claim for intentional interference with economic relations is GRANTED. Defendants are awarded a judgment against Plaintiffs in the amount of \$260,000 minus the credit amount of \$97,551 as set forth above. Judgment is thus entered against Plaintiffs in favor of Defendants in the total net amount of \$162,449.00.
- This Final Judgment resolves all claims of all parties asserted in the litigation with all parties to bear their own fees and costs.
