Summary of Notice of Violation:

7/12/23: While in the area following up with another case, I passed this property and observed the weeds on parts of the property are overgrown as to exceed the 6" height limit. Additionally, there is several miscellaneous junk-like items being stored behind the building that is visible from the street. Also, a tree located near the sidewalk has some low hanging branches (below the 7' height limit) which is obstructing the sidewalk. Photo evidence and documentation added to case file. Required Action by Responsible Person(s): Ryan J. Carr (the "Responsible Party"), shall pay the \$700,00 penalty accrued for the violation of Clearfield City Code Section 5-1-3 after having received a Notice of Violation (NOV) dated July 13, 2023 for failing to maintain weeds, failing to remove junk and discarded household items from the yard area and failure to maintain or remove overgrown trees in violation of 5-1-3 on or about July 12, 2023 and failing to come into compliance or request an inspection by the compliance date. The penalty shall be paid within 15 days following service of this default judgment or the Responsible Party may submit a Motion to Set Aside this default judgment and request a hearing to show good cause why this judgment should be set aside. The Responsible Party shall cure the violations outlined in the NOV within 15 days following service of this default judgment or be subjected to further penalties. If the Responsible Party fails to bring the property into compliance, Clearfield City may enter the yard area to cause the abatement of violations and the Responsible Party shall pay the costs of such abatement.

Payment of the monetary penalty does not relieve the responsible person(s) of the duty to correct the violation. Once the violations have been corrected and/or stopped, the responsible person(s) shall request a compliance inspection and a Notice of Compliance form from the Code Compliance Division to bring this matter to a conclusion. A re-inspection fee of **§150.00** must be paid in advance of scheduling a re-inspection.
