Required Action by Responsible Person(s): DJM24 LLC - C/O JOE JEPSEN (the "Responsible Party") shall pay the \$700.00 penalty accrued for the violation of Clearfield City Code Section 5-1-3 after having received a Notice of Violation (NOV) dated August 15, 2023 for failure to maintain weeds and failure to remove graffition or about August 8, 2023 and failing to come into compliance or request an inspection by the compliance date. The penalty shall be paid within 15 days following service of this default judgment or the Responsible Party may submit a Motion to Set Aside this default judgment and request a hearing to show good cause why this judgment should be set aside. The Responsible Party shall cure the violations outlined in the NOV within 15 days following service of this default judgment or be subjected to further penalties. If the Responsible Party fails to bring the property into compliance, Clearfield City may enter the yard area to cause the abatement of violations and the Responsible Party shall pay the cost of such abatement.

Payment of the monetary penalty does not relieve the responsible person(s) of the duty to correct the violation. Once the violations have been corrected and/or stopped, the responsible person(s) shall request a compliance inspection and a Notice of Compliance form from the Code Compliance Division to bring this matter to a conclusion. A re-inspection fee of \$150.00 must be paid in advance of scheduling a re-inspection.
