NOTICE OF CONSTRUCTION LIEN

To Whom It May Concern:

NOTICE IS HEREBY GIVEN, in accordance to Section 38-11-204 of the Utah Code, that under Utah law, an "owner" may be protected against liens being maintained against an "owner-occupied residence" and from other civil actions being maintained to recover monies owed for "qualified services" performed or provided by suppliers and subcontractors as part of this Contract if, and only if, one of the following conditions is satisfied:

- (1) (a) the owner entered into a written contract with either an original contractor, a factory-built housing retailer, or a real estate developer; and
- (b) the original contractor was properly licensed or exempt from licensure under Title 58, Chapter 55, Utah Construction Trades Licensing Act at the time the contract was executed; and
- (c) the owner paid, in full, the original contractor, factory-built housing retailer or real estate developer, or their successor or assign, in accordance with the written contract and any written or oral amendments to the contract,

(d) An owner who has satisfied all of these conditions may perfect his protection from liens by applying for Certificate of Compliance with the Division of Occupational and Professional Licensing by calling (801) 530-6029 and requesting to speak to the Lien Recovery Fund (Utah Administrative Code R156-38A-108) -or-

- (2) the amount of the general contract between the owner and the original contractor totals no more than \$5,000.

The undersigned, Wayne Olsen, on behalf of Geneva Rock Products, Inc., a Utah Corporation, gives notice of intention to hold and claim a lien upon the real property and improvements thereon owned and reputed to be owned by Fund Those Missions LLC, which property is located in Davis County, State of Utah and is more particularly described as follows: ALL OF LOT 13, WILCOX FARMS AMD.
