**Quit Claim Deed**

The UTAH DEPARTMENT OF TRANSPORTATION, Grantor, by its duly appointed Director of Right of Way, of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIMS to Dr. Kyle J. Eliason, Grantee, at 5540 Shadow Mountain Lane, Ogden, County of Weber, State of Utah, Zip 84403, for the sum of TEN (\$10.00) Dollars, and other good and valuable considerations, the following described tract of land in Davis County, State of Utah, to-wit:

A tract of land situate in the NW1/4 SW1/4 and the NE1/4 SW1/4 of Section 22, Township 4 North, Range 2 West, Salt Lake Base and Meridian. The boundaries of said tract of land are described as follows:

Beginning at the intersection of the southerly boundary line of said entire tract and the southwesterly highway right of way and no-access line of SR-67 West Davis Highway, known as Project No. S-R199(229), which is 2068.77 feet N.00°12'25"E. along the Quarter Section line and 1196.69 feet S.89°53'47"W. from the South Quarter corner of said Section 22; and running thence S.89°53'47"W. 1411.08 feet along said southerly boundary line to the easterly right of way line of 2000 West Street; thence N.00°11'37"E. 111.41 feet along said easterly right of way to a point of curvature of a non-tangent curve to the left with a radius of 20.00 feet; thence southerly along said curve with an arc length of 31.42 feet, chord bears S.44°48'18"E. 28.28 feet; thence S.89°48'14"E. 673.00 feet; thence N.00°11'37"E. 192.70 feet; thence N.89°53'47"E. 107.59 feet to said southwesterly highway right of way and no-access line at a point of curvature of a non-tangent curve to the right with a radius of 5645.30 feet; thence along said southeasterly highway right of way and no-access line the following two (2) courses and distances: (1) southeasterly along said curve with an arc length of 526.57 feet, chord bears S.66°06'28"E. 526.38 feet to a point of curvature of a compound curve to the right

with a radius of 6135.97 feet; (2) thence southeasterly along said curve with an arc length of 144.32 feet, chord bears S.62°41'54"E. 144.32 feet to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation.

The above described tract of land contains 182,423 square feet in area or 4.188 acres.

(Note: Rotate above bearings 00°20'33" clockwise to equal NAD83 Highway bearings of Project No. S-R199(229))

Signs, Billboards, outdoor Advertising structures, or advertising of any kind as defined in 23 United States Code, Section 131, shall not be erected, displayed, placed or maintained upon or within this tract, EXCEPT signs to advertise the sale, hire or lease of this tract or the principal activities conducted on this land.

The grantor reserves rights to use the abutting state property for highway purposes and excludes from this grant any rights to air, light, view and visibility over and across the abutting state property. The Grantee is hereby advised that due to present or future construction on the adjacent highway including but not limited to excavation, embankment, structures, poles, signs, walls, fences and all other activities related to highway construction or which may be permitted within the Highway Right of Way that air, light, view and visibility may be restricted or obstructed on the above property.



Junkyards, as defined in 23 United States Code, Section 136, shall not be established or maintained on the above described tract of land.
