ASSIGNMENT OF EASEMENT

FOR VALUE RECEIVED, Grantsville South Willow Irrigation Company, a corporation organized and existing under the laws of the State of Utah, with its principal office at Grantsville, Tooele County, State of Utah, ASSIGNOR, hereby assigns, transfers and quit claims to Grantsville Irrigation Company, a corporation organized and existing under the laws of the State of Utah, with its principal office at Grantsville, Tooele County, State of Utah, ASSIGNEE, all of Assignors right, title and interest in and to the easement granted to South Willow Irrigation Company by and pursuant to that certain Amended Judgment in the case of The Grantsville South Willow Irrigation Company vs. J.A. Millyard, Civil No. 5454, in the Third Judicial District Court of Tooele County, State of Utah, dated January 25, 1963, for an easement for the maintenance and repair of a pipeline across the lands of Defendant situate in Section 7, Township 3 South, Range 5 West, Salt Lake Base and Meridian, thirty feet (30') in width, that is to say, fifteen feet (15') on either side of the centerline thereof which is more particularly described as follows:

Beginning at a point on a fence line which is 5345 feet South and 4513 feet West of the Northeast Corner of Section 7, Township 3 South, Range 5 West, Salt Lake Base and Meridian, and running thence North 40° 24' East 3482 feet to a diversion weir; thence North 40° 24' East 494 feet to a gate valve which is 2316 feet South and 1936 feet West of the Northeast Corner of said Section 7.

Assignee shall be entitled to all rights of Assignor thereunto belonging and shall assume all responsibilities and obligations of Assignor under said easement.

The officers who sign this Assignment on behalf of Assignor hereby certify that this Assignment was duly authorized under a resolution duly adopted by the Board of Directors of Assignor at a lawful meeting duly held and attended by a quorum of said Board of Directors.
