ASSIGNMENT AND ASSUMPTION AGREEMENT

This ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Assignment") dated as of the dates set forth in the notary certifications below but effective for all purposes as of 7:00 a.m. in Houston, Texas on March 5, 2010 ("Effective Date"), is by and among Ute Energy LLC, a Delaware limited liability company, with an office at Ft. Duchesne, Utah ("Assignor") and Ute Energy Upstream Holdings LLC, a Delaware limited liability company, with an office at Fort Duchesne, Utah ("Assignee").

RECITALS:

1. The Ute Indian Tribe of the Uintah and Ouray Reservation ("**Tribe**"), Bill Barrett Corporation ("**BBC**"), and the Ute Distribution Corporation ("**UDC**"), entered into the Blacktail Ridge Exploration and Development Agreement dated December 22, 2006, (the "**Blacktail Ridge EDA**"), and approved by the Bureau of Indian Affairs ("**BIA**") on February 23, 2007, a memorandum of which was recorded in Duchesne County, Utah on April 23, 2007, in Book M316, Page 534, Entry No. 394685, affecting land in Duchesne County, Utah as more specifically described in **Exhibit A** to this Assignment and incorporated hereto; and, further, the Tribe assigned certain rights and obligations in the Blacktail Ridge EDA, as amended, to Assignor in that Assignment, Assumption, and Bill of Sale, among the Tribe, Jurrius Ogle Group, LLC, and Assignor, dated May 16, 2007 ("**May 16, 2007 Assignment**"); and
2. The Tribe, UDC, and Newfield Production Company ("**Newfield**"), entered into the Monument Butte Exploration and Development Agreement dated December 22, 2006, (the "**Monument Butte EDA**"), and approved by BIA on February 23, 2007, said agreement having been amended July 1, 2009 and approved by BIA December 22, 2009, a memorandum of which was recorded in Duchesne County, Utah on January 29, 2007, in Book M315, Page 49, Entry No. 392274, and in Uintah County, Utah on February 6, 2007, in Book 1016, Page 81, Entry No. 2007001429, affecting land in Duchesne County, Utah and Uintah County, Utah as more specifically described in **Exhibit B** to this Assignment and incorporated hereto; and, further, the Tribe assigned certain rights and obligations in the Monument Butte EDA to Assignor in the May 16, 2007 Assignment; and
3. The Tribe, UDC, Newfield, and Assignor entered into the Bridgeland Exploration and Development Agreement dated July 1, 2008, (the "**Bridgeland EDA**"), and approved by

BIA on October 15, 2008, affecting land in Duchesne County, Utah as more specifically described in **Exhibit C** to this Assignment and incorporated hereto; and

4. The Tribe, UDC, BBC, and Berry Petroleum Corporation ("**Berry**"), entered into the Lake Canyon Exploration and Development Agreement dated July 13, 2004, as amended and restated September 24, 2004 (the "**Lake Canyon EDA**"), and approved by BIA on October 5, 2004, a memorandum of which was recorded in Duchesne County, Utah on November 2, 2004, in Book M305, Page 297, Entry No. 373133, affecting land in Duchesne County, Utah and Wasatch County, Utah as more specifically described in **Exhibit D** to this Assignment and incorporated hereto; and, further, the Tribe assigned certain rights and obligations in the Lake Canyon EDA to Assignor in that Assignment, Assumption, and Bill of Sale, among the Tribe, Jurrius Ogle Group, LLC, Ute Energy Holding LLC, and Assignor, dated May 4, 2005 and approved by BIA on April 22, 2005 ("**May 4, 2005 Assignment**"), and recorded in Duchesne County on August 25, 2005, in Book M308, Page 760, Entry No. 379522 and in Uintah County, Utah on August 31, 2005, in Book 940, Page 842, Entry No. 2005007368, and

5. The Tribe, UDC, and Questar Exploration and Production Company ("**Questar**"), entered into the Wolf Flat Exploration and Development Agreement dated March 31, 2005, (the "**Wolf Flat EDA**"), approved by BIA on May 24, 2005, affecting land in Uintah County, Utah as more specifically described in **Exhibit E** to this Assignment and incorporated hereto; and, further, the Tribe assigned certain rights and obligations in the Wolf Flat EDA to Assignor in the May 4, 2005 Assignment; and

6. Assignor and Questar entered into that Pooling Agreement dated effective September 15, 2006, (the "**Section 36 Pooling Agreement**"), affecting lands in Uintah County, Utah as more specifically described in **Exhibit F** to this Assignment and incorporated hereto.

7. Assignor desires to assign all of its interest in the Blacktail Ridge EDA, Monument Butte EDA, Bridgeland EDA, Lake Canyon EDA, Wolf Flat EDA, and the Section 36 Pooling Agreement and all lands subject to the aforesaid agreements whether or not described in Exhibits A through F (the "Assets"), and Assignee desires to assume all rights and obligations of Assignor in and to the Blacktail Ridge EDA, Monument Butte EDA, Bridgeland EDA, Lake Canyon EDA, Wolf Flat EDA, and the Section 36 Pooling Agreement and all lands subject to the aforesaid agreements whether or not described in Exhibits A through F (the "Obligations").

AGREEMENT

NOW, THEREFORE, for and in consideration of the covenants and promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree, as of the Effective Date, as follows:

1. Assignor hereby conveys, transfers and assigns to Assignee all of Assignor's right, title, and interest in and to the Assets.

2. Assignee hereby accepts the foregoing conveyance, transfer and assignment and assumes all Obligations of Assignor relating to the Assets.

3. Assignor warrants title to the Assets, unto Assignee, its successors and assigns, against all persons claiming or to claim the same or any part thereof by, through, or under Assignor, but not otherwise. **EXCEPT AS PROVIDED IN THE PRECEDING SENTENCE, ASSIGNOR MAKES NO, AND EXPRESSLY DISCLAIMS AND NEGATES ANY, REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, AS TO TITLE TO ANY OF THE ASSETS.** Assignor hereby assigns to Assignee all rights, claims, and causes of action on title warranties given or made by Assignors' predecessors (other than Affiliates of Assignor), and Assignee is specifically subrogated to all rights which Assignor may have against its predecessors (other than Affiliates of the Assignor), to the extent that Assignor may legally transfer such rights and grant such subrogation.

4. The Assets are assigned **AS IS, WHERE IS, AND WITH ALL FAULTS, AND ASSIGNOR MAKES NO, AND EXPRESSLY DISCLAIMS AND NEGATES ANY, REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, AS TO (A) MERCHANTABILITY OF SUCH PERSONAL PROPERTY, (B) FITNESS OF SUCH PERSONAL PROPERTY FOR ANY PARTICULAR PURPOSE, (C) CONDITION OF SUCH PERSONAL PROPERTY, (D) INFRINGEMENTS BY SUCH PERSONAL PROPERTY OF INTELLECTUAL PROPERTY RIGHTS AND (E) CONFORMITY OF SUCH PERSONAL PROPERTY TO MODELS OR SAMPLES OF MATERIALS.**

5. This Assignment shall be binding upon, and inure to the benefit of Assignor and Assignee and each of their respective successors and assigns.

6. As evidence of this Assignment, Assignor and Assignee hereby agree to cause this Assignment to be recorded in the real property records of Duchesne County, Utah, Wasatch County, Utah, and Uintah County, Utah.



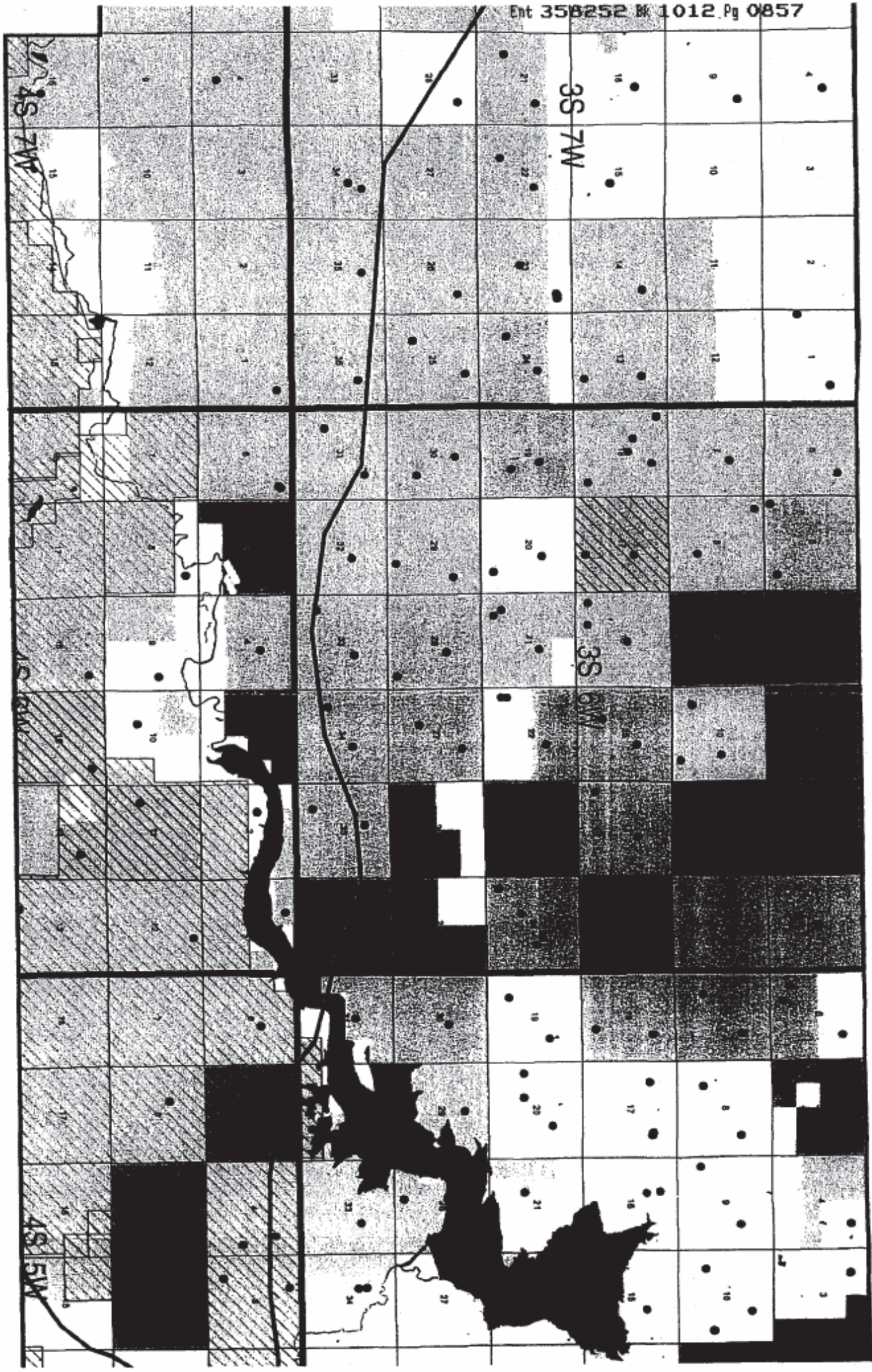
