**THIRD AMENDMENT TO THE  
DECLARATION OF CONDOMINIUM  
FOR  
BLACK ROCK RIDGE CONDOMINIUM  
An Expandable Utah Condominium Project**

This Third Amendment to the Declaration of Condominium for Black Rock Ridge Condominium, an expandable Utah Condominium is made and executed by the Management Committee with the necessary approval of the members of the Black Rock Ridge Homeowners Association, Inc. ("Association"). The contents of this Third Amendment shall take effect upon recording in the office of the County Recorder of Wasatch County, Utah. All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Declaration.

**RECITALS**

**WHEREAS**, the Declaration of Condominium for Black Rock Ridge Condominium ("Declaration") was recorded on September 25, 2006 as Entry No. 308173, Book 894 at Pages 37-107 in the offices of the Wasatch County Recorder.

**WHEREAS**, the First Amendment to the Declaration of Condominium for Black Rock Ridge Condominium was recorded on March 22, 2007 as Entry No. 317471, Book 935 at Pages 935-936 in the offices of the Wasatch County Recorder.

**WHEREAS**, the Supplemental Declaration and Second Amendment to the Declaration of Condominium for Black Rock Ridge Condominium was recorded on May 31, 2007 as Entry No. 320961, Book 941 at Pages 980-992 in the offices of the Wasatch County Recorder.

**WHEREAS**, on April 23, 1999, the Declarant turned over the Association to the owners pursuant to paragraphs 14 and 39 of the Declaration, ending the Declarant's control.

**WHEREAS**, Section 32(b) of the Declaration provides that the Association, after termination of the Declarant's control, may amend the Declaration with the approval of at least sixty-seven percent (67%) of the Owners.

**NOW THEREFORE**, the Association is making the following amendments, which have been approved by at least sixty-seven percent (67%) of the Owners as required by Section 32(b) of the Declaration.

**AMENDMENT ONE**

**NOW THEREFORE**, the Association hereby amends Article III, Section 10 to read as follows:

4. **Leases, Rentals, and Rentals on a Short Term Basis.**

a. There is no restriction on the right of any Owner to lease rent or otherwise grant occupancy rights to a unit.

b. **EACH OWNER BY ACCEPTANCE OF A DEED OR OTHER DOCUMENT OF CONVEYANCE ACKNOWLEDGES AND AGREES THAT THE UNITS MAY BE RENTED ON A NIGHTLY, WEEKLY, MONTHLY, OR OTHER PERIODIC BASIS, AND THAT VACATION AND OTHER SHORT TERM RENTALS ARE PERMITTED.**

c. Short term rentals of every kind are allowed, subject to the condition that Owners who rent their Units for an initial term of less than thirty (30) days ("Short Term Basis") shall:

1) Use a professional rental management company, duly licensed and qualified in the State of Utah, which shall provide the following:

- a. 24-hour management services;
- b. Have all necessary business and other licenses or permits required by the county or state;
- c. Provide 24-hour professional rental management company assistance phone number to each customer renting on a Short Term Basis.

d. Maximum occupancy of any rental unit shall not exceed two people per bedroom.

e. Owners are responsible for the actions and behavior of their tenants. Owners shall review the Declaration, Bylaws, and any rules and regulations with their tenants to ensure compliance. A tenant's violation of the terms of the Declaration, Bylaws or rules and regulations may result in a fine that is the responsibility of the Owner.

**AMENDMENT TWO**

**NOW THEREFORE**, the Association hereby amends Article III, Section 8(e)(11)(e) of the Declaration, to read as follows:

e. Residents may only park their motor vehicles within their designated garages, driveways, or other designated Common Areas. No vehicles of any type may be parked on the streets overnight, or at any time or in any manner which impedes snow removal.

**AMENDMENT THREE**

**NOW THEREFORE**, the Association hereby amends Article III, Section 8(e)(12) to read as follows:

(12) Aerials, Antennas, and Satellite Systems. No radio or television antenna, aerial, satellite dish, or similar receiving mechanism shall be installed on the outside of any Unit or any building contained within the Project without the approval of the Management Committee. In the event that the Management Committee approves the installation and location of such device (which it is not required to do) such approval is strictly limited to one (1) such device per building and said device shall serve the common good within that building.”

**AMENDMENT FOUR**

**NOW THEREFORE**, the Association hereby amends Article III, Section 5 to read as follows:

5. Limited Common Areas. Limited Common Areas mean those parts of the Common Areas and Facilities which are limited to and reserved for the use of the Owners of one or more, but fewer than all, of the Units. Without limiting the foregoing, the Limited Common Areas and Facilities shall include any balcony, deck, patio, entryway, or porch adjacent to a Unit, garages and driveways located outside of such Units, and all such items designated as Limited Common Areas and Facilities on the Plat or as provided for by the Act. There shall be no modifications or structural alterations of any kind to the Limited Common Areas without the written approval of the Management Committee.

(a) Garages. Garages shall be Limited Common areas. Some garages are located within the stacked Unit Buildings and there are garage buildings across the street from the Buildings containing ten (10) individual garages. Each Owner shall be permitted to designate one (1) garage that is either appurtenant to the Owner's Unit or is located within the garage to the individual Unit shall be legally described in the Declarant's deed of conveyance of the Unit and designated garage and then recorded in the Office of the Wasatch County Recorder. Individual garages identified as set forth in Exhibit B of the Supplemental Declaration and Second Amendment to the Declaration of Condominium for Black Rock Ridge Condominium. The Owner's assigned garage shall be for the exclusive use of the Owner. Except in case of

emergency repair, no structural alterations, plumbing, electrical, or similar work within the garage shall be done or permitted by any Owner without prior written consent of the Management Committee. All mechanical equipment and appurtenances located within a garage or located outside of a garage but designed and designed to serve only that particular garage (including garage doors, garage door mechanisms, side doors, and any interior or exterior fixtures) shall be considered part of the Unit to which said garage is assigned.

(b) Use. The deck, balcony, patio, or garage which are accessible from, associated with, assigned to, and/or adjoin a particular Unit, without further reference thereto, shall be used in connection with such Unit to the exclusion of the use thereof by the other Owners, except by invitation. Limited Common Areas, including but not limited to balconies, decks, patios, and garages, may not be partitioned from the Unit to which they are appurtenant. The exclusive use of Limited Common Areas is reserved to the Unit to which it is assigned in Exhibit B of the Supplemental Declaration and Second Amendment to the Declaration of Condominium for Black Rock Ridge Condominium, and/or the Condominium Plat, as amended from time to time. No reference thereto need be made in any instrument of conveyance, encumbrance, or other instrument. The use and occupancy of designated Limited Common Areas and Facilities shall be reserved to the Units as shown on the Plat, as designated from time to time by the Management Committee, or as specified in the Declaration. Owners may not reallocate Limited Common Areas and Facilities between or among Units in which they have an interest. Notwithstanding, the Association has the right to reallocate Limited Common Areas and Facilities, including garages, to the fullest extent permitted under the Act.

#### AMENDMENT FIVE

**NOW THEREFORE**, the Association hereby amends Article III, Section 7 to read as follows:

7. Architectural and Design Guidelines. The Declarant has prepared Design Guidelines for the Project, which have been approved by the County. The County reserves the right to and may enforce any Design Guidelines at any time in its sole discretion, and for this purpose the County is hereby designated a third party beneficiary of this agreement. The approved Design Guidelines shall apply to all construction activities within the Project. The approved Design Guidelines may not be at any time changed, amended, or supplemented without the express written consent of the County. The Declarant or, after transition of the Project, the Association must stamp all proposed plans and specifications to construct or remodel a Building or Unit "approved and in compliance with the Declaration and Design Guidelines" before presenting such plans and specifications to the County for the issuance of a building permit. The Declarant, or the Association following transition of the Project, does not make any assurances that structures, if any, erected on any portion, part, or the whole of Additional Land will be compatible with structures on land originally within the Project in terms of quality of construction, principal materials used, and architectural style.

Once a Unit is complete and a certificate of occupancy has been issued, all exterior modifications to the Unit or any modification to the Limited Common Areas pertaining to said Unit shall receive prior written consent of the Management Committee. The Management

Committee shall appoint Members to serve on an Architectural Control Committee. The Architectural Control Committee may consist of up to seven (7) Members, all of which are appointed by the Management Committee. Any requests to the Management Committee for written approval to make any exterior modifications to a Unit or any modifications to the Limited Common Areas shall be reviewed first by the Architectural Control Committee. The Architectural Control Committee shall investigate the request and make a recommendation to the Management Committee. Regardless of the recommendation, the Management Committee shall have the exclusive authority to make the final decision. Until there are at least sixteen (16) different Owners, the Management Committee shall act as the Architectural Control Committee.


