## NOTICE OF REINVESTMENT FEE COVENANT

Pursuant to Utah Code Annotated Section 57-1-46(7)(a), Tuhaye Home Owners Association, a Utah non-profit corporation (the "Association") hereby gives notice of a "reinvestment fee covenant" (as that term is defined in Section 57-1-46(1)(i)), which reinvestment fee covenant burdens all that real property described on Exhibit A attached hereto and incorporated herein by this reference, and will burden all of the real property described on Exhibit B attached hereto and incorporated herein by reference ("Additional Land") if and when such Additional Land is subjected to the Master Declaration pursuant to Section 2.2 thereof.

The reinvestment fee covenant was created by and is set forth in Section 6.11 of the Declaration of Covenants, Conditions and Restrictions for Tuhaye, a Planned Community, recorded on June 4, 2003, as Entry No. 258750 at Book 0628 at Page 0770 of the records of the Wasatch County Recorder, as supplemented and/or amended from time to time (the "Master Declaration").

The reinvestment fee covenant requires, among other things, that **upon any transfer (as defined in section 6.11.2 of the Master Declaration) of any of the real property described on Exhibit A attached hereto or any of the Additional Land described on Exhibit B attached hereto which is hereafter subjected to the Master Declaration, the transferee is required to pay a real estate transfer assessment** determined in accordance with Section 6.11 of the Master Declaration, *unless* the transfer is expressly excluded from the definition of a "transfer" pursuant to Section 6.11.2 of the Master Declaration.

The burden of the reinvestment fee covenant is intended to run with the land and to bind successors in interest and assigns.

The duration of the reinvestment fee covenant is twenty (20) years from the date the Declaration was recorded, which duration shall be automatically extended for successive periods of ten (10) years each, unless the Declaration is terminated pursuant to Section 9.2 of the Declaration.
