A strip of land 15 feet wide running parallel to and adjoining the West 264.3 foot boundary of the following described tract of land as described on the records of the Weber County Recorder:

Part of the NW $^1_4$  of Section 29, T7N, R1W, Salt Lake Meridian, U.S. Survey, described as follows:

Beginning at a point on the South line of the County Road at a point 634 feet West and 985 feet North and North 60° 30' West, 219.06 feet from the Southeast corner of said Quarter Section, and running thence South 17° 18' West 233 feet; thence North 60° 30' West 325.56 feet to the West line of Ellen L. Bailey's property; thence North along old fence line 264.3 feet to the South line of County Road; thence South 60° 30' East along the South line of County Road a distance of 410.44 feet more or less to the place of beginning.

Together with a temporary easement during the construction of the pipeline and appurtenant structures for construction purposes in, over, upon and across a strip of land 30 feet wide adjoining the property.

Grantee, by accepting this grant, agrees to replace or repair, with materials of like kind and equal quality, any existing fences, ditches, pipelines, driveways or roadways, including the appurtenances thereto, damaged or destroyed in said construction, and will restore the surface as near as can be to its original condition within the easement area.
