SUPPLEMENTARY DECLARATION TO THE

DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS CONCERNING THE OLD FARM COMMUNITY PHASE I

THIS SUPPLEMENTARY DECLARATION is made and executed on the 30 day of December, 1981 by OLD FARM HOMEOWNERS ASSOCIATION, a Utah non-profit corporation (the "Declarant").

RECITALS:

- A. On June 13, 1974, Richard Prows, Inc., as "Developer", made and executed that certain instrument entitled "Declaration of Covenants, Conditions and Restrictions Concerning the Old Farm Community, Phase I"(the "Declaration") as the initial part of a program for multiple condominium projects in the area of the land subjected to the provisions thereof. The Declaration was recorded in the official records of Salt Lake County, State of Utah, on June 19,1974 in Book 3613 at pages 431-447 as entry no. 2630430. The Declaration submitted to its provisions the parcel of real property situated in Salt Lake County, State of Utah, particularly described in Article II thereof.
- B, Under the Declaration (Section 1 of Article IX) the Developer reserved the right to expand the Common Properties.
- C. Declarant is the record owner of the Parcels of real property described in ARTICLE II (the "Additional Parcels") of this Supplementary Declaration. The Additional Parcels constitute a portion of the Entire Tract defined in the Declaration.
- D. It is the intent and purpose of the Declarant that all of the Additional Parcels shall become subject to the Declaration. To this end and for the benefit of the members of the Association, being condominium unit owners in the Old Farm community, Declarant makes this Supplementary Declaration.

NOW, THEREFORE, for the foregoing purposes, Declarant hereby makes the following Supplementary Declaration:

I. DEFINITION

Except as otherwise defined herein or as may be required by the context, all terms or expressions defined in Article I of the Declaration shall have such defined meanings

when used in this Supplementary Declaration (including in that portion headed "Recitals").

II. DEFINITIONS

Declarant hereby submits to the provisions of the Declaration, as additional Common Properties of the Association, the Parcels of real property situated in Salt Lake County, State of Utah, described in EXHIBIT "A" attached hereto and made a part hereof.

III. IMPROVEMENTS ON COMMON PROPERTIES

The improvements, in general, located upon the Additional Parcels consist of roads, clubhouse known as the "Community Center Building", tennis courts , and maintenance shop building.

IV. AFFIRMATION OF INTENT

The Additional Parcels, and each of them, are hereby declared to comprise a portion of the Common Properties of the Association as if originally included in the Declaration and the same shall be, and hereby are, subject to all of the provisions of the Declaration.

V, EFFECTIVE DATE

This Supplementary Declaration shall take effect upon it being filed for record in the office of the County Recorder of Salt Lake County, Utah.
