NOTICE OF WAIVER OF DECLARANT CONTROL

The Rose Owners Association, Inc.

This NOTICE OF TERMINATION OF PERIOD OF DECLARANT CONTROL (the “**Notice**”) is made and executed by CW South Davis Rose, LLC, a Utah limited liability company (the “**Declarant**”).

RECITALS

A. CW South Davis Rose, LLC, is the Declarant of The Rose Owners Association, Inc., a Utah non-profit company (the “**Association**”), under the Declaration of Covenants, Conditions, and Restrictions, and Reservation of Easements for The Rose, recorded in the Office of the Davis County Recorder on October 27, 2021, as Entry Number 3430697 (the “**Declaration**”).

B. The Declaration affects the real property situated in Farmington, Davis County, Utah, described with particularity on Exhibit A (the “**Project**”).

C. The Project is governed by the Association.

D. Under the Declaration, the Declarant has certain rights to govern the Project and the Association during the Declarant Control Period.

E. The Owners convened and elected a Board of Directors on or about October 2, 2025.

F. Pursuant to Section 1.18 of the Declaration, the Declarant Control Period may be terminated through a recorded written waiver executed by the Declarant terminating the Declarant Control Period.

G. The Declarant desires to waive, and thus terminate, the Declarant Control Period.

H. Unless otherwise provided, capitalized terms used herein shall have the same meaning and effect as used in the Declaration.

WAIVER

NOW THEREFORE, in consideration of the recitals set forth above, the Declarant hereby declares and certifies as follows:


1. The Declarant hereby waives, and thus terminates the Declarant Control Period, as defined by Section 1.18 of the Declaration.
2. The Association shall be governed by a Board of Directors consisting of Owners in the Project pursuant to the terms of the Declaration and Bylaws of the Association.
3. The Declarant hereby ratifies all decisions made by the Board of Directors elected by the Owners from their election on October 2, 2025, to the date this Notice is recorded against the Project.
4. The Declarant shall retain all other rights under the Declaration that do not expressly terminate at the end of the Declarant Control Period.

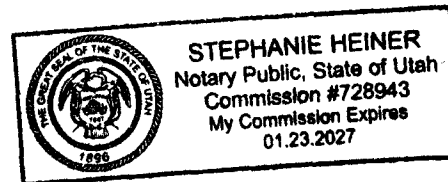
