AGREEMENT

THIS AGREEMENT, made and entered into this 30 day of November,  
1971, by and between Nibley Blacksmith Fork Irrigation Company, party  
of the first part, and Hesston of Utah, a corporation, party of the  
second part.

W I T N E S S E T H

THAT WHEREAS, the canal of the party of the first part as now  
constructed and has been located for many years last past, courses  
generally north and south across the property of the party of the  
second part, described as follows:

The East 59 Rods of the Southwest quarter  
of the Northwest quarter of Section 21  
Township 11 North, Range 1 East; Except  
1.11 acres conveyed to the OSLRR for the  
right-of-way; Net area 28.39 acres more  
or less.

as an open canal, and

WHEREAS, the party of the second part desires the right to build  
over the canal which will involve enclosing the canal in a pipe, a  
distance of approximately 400 feet and which pipe may be in the nature  
of a siphon, to enable it to go under the building.

NOW THEREFORE, IT IS AGREED AS FOLLOWS:

1. That the party of the first part hereby grants to the party  
of the second part the right to reroute the canal in a slightly dif-  
ferent direction as it crosses the said property, and to enclose it  
in a pipe in such a manner that the canal can carry at least but not  
more than 7 C.P.S. of water. That the maintenance of the open canal  
will be maintained by Nibley Blacksmith Fork Irrigation Company. The  
maintenance of the pipe and siphon portion thereof will be maintained  
by the party of the second part.

2. In case of the plugging of the said pipeline or siphon, the party of the second part agrees to restore the normal flow within a period of five days to meet the irrigation time cycle.

3. It is further understood and agreed that the change of the location has been partially completed and designates the routing which will be used. It is agreed that the siphon will be tested and approved by the party of the first part prior to the 1972 irrigation season.

4. The party of the second part will provide to the party of the first part, a surveyed print of the location of the said pipeline.

5. If the building shall be removed or for any reason the pipeline is abandoned, then the party of the second part and its successors agree at their expense to restore the open canal to a similar operation as before the pipeline was constructed.

6. This agreement shall be binding upon the parties hereto, and their successors in interest, and shall be recorded in the office of the County Recorder of Cache County, Utah.


