RIGHT-OF-WAY AGREEMENT

WATER & SEWER LINES

TERTELING LAND COMPANY, a corporation

organized and existing under the laws of the State of Idaho, with its principal office at Idaho

Boise, of County of Ada State of Idaho

grantor, hereby convey and warrant to Bountiful, a Municipal Corporation, organized and existing under the state laws of Utah, Grantee, its successor and assigns for the sum of One Dollar, and other good and valuable consideration, receipt of which is hereby acknowledged, a perpetual right of way and easement for the purpose of digging, laying, connecting to and maintaining, cleaning and operating an 8 inch sanitary sewer line across the following described tract of land: 10 ft. wide sewer easement 5 ft. each side of the following described center line:

Beginning at a point on the North Line of a Bountiful City Street (1800 South Street) at a point which is West 1826.73 ft. and N 31°15'30" E 25.68 ft. and S 88°44' W 305.39 ft. along the North line of said Street from the North 1/4 corner of Section 31, T.2N., R.1 E., S.L.B. & M. and running thence N 19°30' E 140.0 ft.; thence N 58°30' W 137.00 ft.; thence N 28°00' E 125.00 ft. more or less to an existing sewer manhole.

To have and to hold the same unto Bountiful, its successors and assigns so long as such pipe line or lines shall be maintained with the right of ingress and egress along said right-of-way, and to maintain, operate, and replace the same. The said Grantors to fully use the said premises except for the purpose for which this right-of-way or easement is granted to the said Grantee.
