**AFFIDAVIT
 OF ADDRESS CHANGE**

The undersigned, having duly sworn,
 hereby deposes and says as follows:

1. I am a resident of Utah County, State of Utah, over the age of twenty-one years and in all respects competent to testify to the matters contained herein.
2. I am currently employed as the Building Official of Tooele City and I am authorized by City ordinance to change addresses for public safety reasons.
3. I am familiar with the certain plat of Overlake Estates Phase 1C, recorded as entry no. 107635, book 493, page 445, in the Tooele County Recorder's Office, State of Utah.
4. I am also familiar with a certain amended plat of Overlake Estates Phase 1C which was approved by the City Council but never recorded by the developer but contains amended addresses which were used by the City Building Department.
5. Because the amended plat was never recorded but the amended addresses were used, many homes are using addresses which are now listed incorrectly on the recorded plat and this can delay home sales or refinances.

Therefore the official addresses of certain lots listed below, located in Overlake Estates Phase 1C plat, must be corrected to reflect the amended addresses used on the houses:

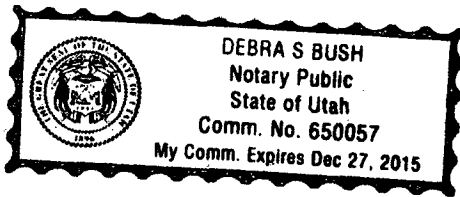
