SALT LAKE CITY ORDINANCE  
No. 50 of 1981  
(Vacation of a Portion of an Alley in  
Block 5, Emerson Heights Subdivision)

AN ORDINANCE VACATING A 150-FOOT PORTION OF A 12-FOOT ALLEY  
AT APPROXIMATELY 1467 SOUTH FROM APPROXIMATELY 1425 TO 1432 EAST  
BETWEEN ROOSEVELT AND EMERSON AVENUES.

Be it ordained by the City Council of Salt Lake City, Utah:

SECTION 1. That a 150-foot portion of the 12-foot alley  
running parallel between Roosevelt and Emerson Avenues at  
approximately 1467 South in Salt Lake City, from approximately  
1425 to 1432 East in Salt Lake City, more particularly described  
below, be, and the same hereby is, vacated and declared no longer  
to be needed or available for use as a public street, avenue,  
alley or pedestrian way.

COMMENCING at the Northeast corner of Lot 12, Block 5,  
Emerson Heights Subdivison, a subdivision of Block 11,  
5-Acre Plat "C", Big Field Survey; thence running East  
150 feet, more or less, along the north lot lines of  
Lots 12-17 to the Northwest corner of said Lot 17;  
thence North 12 feet, more or less, to the Southwest  
corner of Lot 32; thence West 150 feet, more or less,  
along the south lot lines of Lots 32-37, to the South-  
east corner of Lot 37; thence South 12 feet, more or  
less, to the point of BEGINNING.

Said vacation is expressly made SUBJECT TO all exist-  
ing rights of ways and easements of all public utili-  
ties of any and every description, now located on, in,  
under or over the confines of the above-described  
property and also SUBJECT TO the rights of entry  
thereon for the purpose of obtaining, altering,  
repairing, replacing, removing, or rerouting said  
utilities and all of them.

Said vacation is also SUBJECT TO any existing rights  
of way or easements of private third parties.

SECTION 2. This ordinance shall take effect thirty days  
after the date of its first publication.
