All of Salt Lake County's interest in that portion of a road known as 11800 South Street located in Sections 21 and 28, Township 3 South, Range 2 West, Salt Lake Base and Meridian, from its intersection with State Highway #U-111 Westerly to the West line of said Sections 21 and 28 (a distance of approximately one-half mile).
