FASSIO EGG FARMS, INC., a Utah corporation, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby GRANTS AND CONVEYS to Tooele County, Grantee, for the sum of Ten Dollars, and other good and valuable considerations, the following described easement in Tooele County, State of Utah, to wit:

A perpetual easement, upon part of an entire tract of property in the SW1/4NW1/4 of Section 23, T. 2 S., R. 4 W., S.L.B. & M., for the purpose of constructing cut and/or fill slopes and appurtenant parts thereof to facilitate the construction of Droubay Road known as Project No. R299. The easement includes the right to maintain and continue the existence of said cut and/or fill slopes in the same grade and slope ratio as constructed by UDOT. The Easement shall run with the Real Property and shall be binding upon the Grantor and the Grantors successors, heirs and assigns, and includes and conveys all rights of grantor to change the vertical distance or grade of said cut and/or fill slopes. The boundaries of said part of an entire tract are described as follows:

Beginning in the westerly boundary line of said entire tract, at a point 1,536.72 ft. S. 00°22'49" E. (Record = South) along the section line, and 25.64 ft. N. 89°37'11" E. from the Northwest corner of said Section 23, which point is 31.21 perpendicularly distant easterly from the Droubay Road Right of Way Control Line, opposite Engineer Station 20+87.07; and running thence N. 00°00'00" E., 224.90 ft. along said westerly boundary line to the north line of said entire tract; thence S. 89°40'33" E. 33.55 ft. to a point 61.45 ft. perpendicularly distant easterly from the Droubay Road Right of Way Control Line, opposite Engineer Station 23+11.59; thence S. 11°49'02" W. 163.84 ft.; thence S. 17°48'09" E. 35.01 ft.; thence S. 19°02'25" W. 32.81 ft. to the point of beginning.

The above described part of an entire tract contains 3,038 square feet in area or 0.070 acres, more or less.
