listed No. 36 on Page 17 of the judgment and decree of Case No. 7487 in the

which decree awards to the Wilson Irrigation Company 64.13 second feet at flood  
stage, 50.39 second feet at high water, and 27.13 second feet at low water to  
be diverted from the Weber River for use in irrigating land in Sections 3-8,  
17, 20, T5N, R2W; Sections 22, 23, 25-29, 32, 33, 34, 35, T6N, R1W, SLB&M.
