Duffin Grantee, of Provo City Utah for the sum of Six Thousand (\$6000.00) DOLLARS, the following described tract of land in Mapleton Utah County, State of Utah, to-wit:

Beginning 20 chains East of the North West Corner of the North West Quarter of Section 22 Township 8 South of Range 3 East of Salt Lake Meridian; Thence South 30.00 chains thence East 10.00 chains thence North 30.00 chains; thence West 10.00 chains, to the place of beginning. Area 30 acres.

Subject to the taxes for 1911, and thereafter which Grantee herein assumes and agrees to pay.

WHEREAS There has been deposited in the GENERAL LAND OFFICE of the United States a Certificate of the Register of the LAND OFFICE at Salt Lake City, Utah Territory, whereby it appears that, pursuant to the Act of Congress approved 20th May, 1862, "TO SECURE HOMESTEADS TO ACTUAL SETTLERS ON THE PUBLIC DOMAIN," and the acts supplemental thereto, the claim of Leven Simmons has been established and duly consummated, in conformity to law, for the

South West quarter of the South East quarter of Section thirty-two in Township nine South of Range four East and the lot numbered two and the North half of the South East quarter of Section five in Township ten South of Range four East of Salt Lake Meridian in Utah Territory containing one hundred and sixty acres and fifty hundredths of an acre, according to the Official Plat of the Survey of the said Land, returned to the GENERAL LAND OFFICE by the Surveyor General:

Now Know Ye, That there is, therefore, granted by the UNITED STATES unto the said Leven Simmons the tract of Land above described:

TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said Leven Simmons and to his heirs and assigns forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts, and also subject to the right of the proprietor of a vein or lode to extract and remove his ore therefrom, should the same be found to penetrate or intersect the premises hereby granted, as provided by law.

IN TESTIMONY WHEREOF, I, Benjamin Harrison, President of the United States of America, have caused these letters to be made Patent, and the seal of the General Land Office to be hereunto affixed.

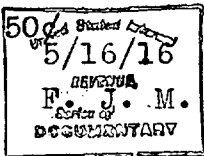
