PacifiCorp, an Oregon corporation, dba Rocky Mountain Power, grantor, and a successor in interest of Snake Creek Power Company, Knight Power Company, Utah Power & Light Company by merger, consolidation, stock acquisition, asset purchase or other similar transaction, hereby assigns to Heber Light & Power Company, a Utah energy services interlocal agency, grantee, the Easement executed on November 13, 1995, and recorded on December 1, 1995, at Page 278, of Book 311 in the Office of the Wasatch County Recorder and quitclaims to Heber Light & Power Company, for the sum of ten dollars and other good and valuable consideration, the right-of-way, easements, and utility assets located on the following described tract of land in Wasatch County, Utah, to wit:

A right of way 10 feet in width, being 5 feet on each side of the following described survey line:

Beginning on the west boundary line at a point 412 feet north and 1289 feet west, more or less, from the southeast corner of Section 4, T.4 S., R.6 E., S.L.M., thence N.62°19'E. 581 feet, more or less, thence N.1°41' E. 80 feet, thence N.45°59'E. 249 feet, thence N.30°04'E. 134 feet, thence N.30°08'W. 123 feet, thence N.25°03'E. 193 feet, thence N.5°17'W. 421 feet on said land and being in the E1/2 of the SE1/4 of said Section 4.

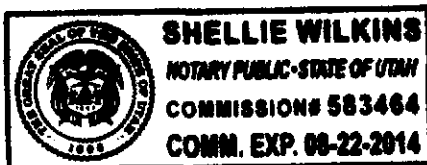
