COTTONWOOD DEVELOPMENT, a Utah Corporation, Grantors, of Salt Lake County, State of Utah, for and in consideration of TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby grant and convey to the SALT LAKE COUNTY WATER CONSERVANCY DISTRICT, Grantee, its successors and assigns, a non-exclusive temporary construction easement and perpetual pipeline easement as hereinafter described.

The easement hereby granted consists of perpetual right of ingress and egress to the land hereinafter described, together with the perpetual right to construct, reconstruct, operate, repair, replace and maintain a culinary water pipeline and appurtenant structures over, under, across and through a strip of land twenty feet (20') in width, and a temporary initial construction easement, over, under, across and through a strip of land thirty feet (30') in width, being more particularly described as follows:

The easement referred to above and granted hereby lies in those portions of Grantor's land situated in Section 21, Township 3 South, Range 1 East, Salt Lake Base and Meridian as follows:

A strip of land 20 feet wide, lying 10 feet on either side of, adjacent and parallel to the following described line:

§6 Beginning at a point on the grantors Westerly property line, said point being more or less North 1195.28 feet and East 1360.94 feet from the South Quarter Corner Section 21, T3S, R1E, SLB&M, thence S 83°50'42" E 89.78 feet; thence S 77°51'18" E 722.71 feet more or less to the grantors Easterly property line. §8

This easement also includes a 30-foot temporary construction easement, lying northerly, parallel and adjacent to the above described permanent easement.

Grantors represent and warrant that they are the sole owners of the land burdened by this easement and that they have full right and authority to grant the easement hereby granted and conveyed.

This easement is subject to the terms and conditions set forth in that certain Agreement for Easement by and between the parties dated the 14<sup>th</sup> day of December, 1982.
