GRANT OF EASEMENT AND RIGHT-OF-WAY, GIVEN THIS 23<sup>rd</sup> day of April, 1983 by and between ERNEST D. DRURY and GLORIA B. DRURY, his wife, and GLEN W. GARDINER and ETHEL FARR GARDINER, his wife, of Salt Lake County, State of Utah, herein referred to as "Grantor," and JAMES L. SORENSEN of Salt Lake County, State of Utah, hereinafter referred to as "Grantee;"

Grantor, for this consideration of Ten (\$10.00) Dollars and other good and valuable consideration paid by Grantee, the receipt of which is hereby acknowledged, hereby grants and warrants to Grantee, his successors and assigns, an easement and right-of-way being described as follows:

The East 30 feet of Lot 1, GARDINER ESTATES, according to the official plat thereof as recorded in the County Recorder Office of Salt Lake County, Utah.

Grantors reserve and retain for themselves and their successors and assigns the right to use the easement and right-of-way for ingress and egress and for all other purposes not inconsistent with Grantee's use of the easement and right-of-way. Grantors agree to dedicate their interest in the easement and right-of-way to the governing municipality upon request of Grantee.

Grantor shall have no responsibility for the costs of any ~~any~~ <sup>improvements</sup> placed within the easement and right-of-way. Neither Grantor nor Grantee shall assume any liability for any act or omission committed by the public on said easement. All such costs shall be the responsibility of Grantee, his successors and assigns.
